# MINUTES

## OF THE

### PANTHER CREEK ASSOCIATION.

FIRST DAY, FRIDAY, AUGUST 23rd, 1895.

Introductory discourse was delivered by Eld. D. B. Voyles from St. John, 17th Chapter and 18th Verse, "As Thou Hast sent Me Into the World, Even So Have I Also Sent Them Into the World." The Association then proceeded to organize. In the absence of Bro. A. Hopper, our former Clerk, Eld. F. D. Baughn, was appointed Clerk to organize. Letters from the several churches were called for, read and the Messenger's name enrolled.

The Association met according to adjournment. The rules of decorum not being present, the Moderator requested a strict compliance to them.

From Blackford; Elds. C. B. Coleman and A. W. McDaniel. From Green River; Eld. P. W. Pharris. From Jasper River; Eld. H. V. Royal.

vans. As a committee on Obituary: Eld. G. W. Jones and Bro. J. T.

Called for report of the committee on Baptist Minister's Aid Society. Report received and committee discharged, and Eld. C. M. Carley was appointed as a committee to receive contributions for the same and report at our next annual session.

Agreed that the Moderator appoint a committee on program of Arrangements. Whereupon was appointed Elds. G. H. McKinney, J. R. Baughn and Bro. G. F. Hopper.

Called for a report on District Missions, which was as follows: Paid for Mission purposes the past year, \$5.70; amount on hand, \$15.40, F. D. Baughn, Treasurer.

The committee on Divine Services reports as follows: Elds. P. W. Pharris, A. W. McDaniel at Sugar Grove Friday night; Elds. G. H. McKinney, J. B. Salmon at Magan Friday night; Elds. P. W. Pharris, C. M. Carley at the Stand Saturday; Elds. J. R. Baughn, A. W. Dodson at Sugar Grove Saturday night; Elds. P. W. Pharris, G. W. Jones at Magan Saturday night; Elds. P. W. Pharris, G. W. Jones, C. M. Carley, G. H. McKinney at the Stand on Sunday.

Adjourned to meet at 8:30 o'clock Saturday morning.

## SECOND DAY, SATURDAY, AUGUST 24th

The Association met at 8:30 a. m. Prayer by J. P. Nelson. Roll called and a corum present. The rule of decorum was read and a strict compliance of the same requested by the Moderator. Called for program of business. Report received and committee discharged.

Agreed that our next Association be held with West Point church, one and one-half miles west of Roseville on the Roseville and Pellville road, Hancock county, Ky., beginning on Friday morning before the Fourth Saturday in August, 1896.

Agreed that Eld. C. M. Carley preach the next Introductory discourse and Eld. D. B. Voyles be his alternate.

Agreed that the Moderator appoint a committee to write a corresponding letter and have it printed in our Minutes, when Eld. C. M. Carley was appointed.

Agreed to grant Friendship church her request, by giving a letter of dismission. Motion made and seconded to drop correspondence; vote taken and motion voted down.

Agreed that the Clerk superintend the printing of the Minutes and the distribution of the same.

The Moderator appointed E. M. Morrison to receive contributions for printing Minutes. Received \$7 75, with \$1 50 in the Treasury making a total of \$9 25.

Agreed that the Moderator appoint a committee on Resolutions; to

whom was appointed Eld. G. W. Jones and Bro. J. T. Funk.

We, your committee on Obituaries, report as follows: WHEREAS, God has called from their earthly labors Bros. John P. Taylor and D. W. Voyles; therefore we take this opportunity of extending our sympathy to the bereaved friends, feeling that the several churches and communities have each lost kind friends and willing workers in the Master's cause.

The letter of correspondence was read and received to wit: Corresponding letter from Panther Creek Association to her sister Association with whom we are in correspondence:

"Dear Brethren: We are now holding our Fifty-Third Annual Session with the Sugar Grove church, Ohio county, Ky., Aug. 23, 1895. Our delegation is some larger this time than it was last session, although the ingatherings have been small; Brethern, we hope that through your prayers and labors, with ours, that God will abundantly bless us this year. Our next Association will convene with West Point church, Hancock county, Ky., on Friday before the Fourth Saturday in August, 1896, when we hope to meet many of our beloved corresponding Brethren.
