- 7. Ministering brethren present were invited to a seat in counsel.
- 8. On motion, the Letter from Bethel Church was taken up, and referred to a committee consisting of George Waller, Wm. Vaughan, A. D. Sears, E. G. Berry, John McCoy, S. Thomas, and W. W. Gardner.
- 9. The delegates from the church at Harrod's Creek, were requested to ap Point preachers to occupy the stand on Saturday; and S. Woodruff, J. D. Crabs, and E. G. Berry were appointed.

- 10. On motion, the subject of Indian Missions was referred to a select committee, consisting of John Dale, J. C. Waller, and G. B. Реск.
- 11. Voted, that a collection be taken on Sabbath, and equally divided between the Am. Ind. Miss. Ass. and the Am. and For. Bible Society.
  - 12. Appointed the Moderator and Clerk a Committee of Arrangement.
- 13. Appointed Wm. B. BARNETT, B. C. Stevens and G. W. Robinson a committee to write to corresponding Associations.
- 14. Adjourned to 9 o'clock, A. M., to-morrow. Prayer by W. W. GARDNER.

- 15. The roll was called.
- 16. Received the report of the Committee of Arrangements.
- 17. The committee on the case of Bethel Church, now applying for admission into this body, reported; and, after a full discussion of the subject, and an amendment of the report, it was adopted as follows:

WHEREAS, it is reported that the difficulty which has arisen in the Bethel church has terminated in a split of the church, and the Middle District Association having recognized a part of the church, at their late session at Beach Creek, to the injury of the Bethel church; and the Bethel church asking for admission into our fellowship, therefore,

Resolved, That this Association recommend to the Middle District Association, to hold a called meeting, and that the parties at Bethel be urged to call a council of brethren to settle the matters of difference between them.

Resolved. That during the time that these difficulties continue, Bethel church, now applying for admission, be considered under the watch care of this Association.

- 18. The Circular Letter was read, and adopted.

- 20. Resolved, That any member of this Association presenting a copy of our minutes to a corresponding body, be considered a delegate.
- 21. The Committee on Indian Missions reported, and the report was adopted, as follows:

The Committee, to whom was referred the subject of Indian Missions, beg leave to report as follows:

Your committee have learnt, with much satisfaction, that contributions of this Association, and of individuals and public bodies within the hounds of this Association, have been successfully applied to the spiritual benefit of the Indians. God has graciously smiled upon this work of benevolence, in which we have the privilege of co-operating. Conversions have occurred, and the desire to enjoy the blessings of the gospel continues to increase among various tribes.

The adoption of the following resolution is respectfully recommended:

Resolved, That as the claims of the Aborigines of our country are evidently stronger upon christians in this country than those of any heathen more remote; and as great encouragement to future action in their behalf is furnished by the success of the past, and the inviting prospects of the future; therefore, the benevolent are earnestly recommended to direct their efforts specially to the promotion of missions among them, under the patronage of the American Indian Mission Association.

The following brethren were appointed correspondents to attend the next annual meeting of the American Indian Mission Association, viz: J. Kinsolving, G. B. Peck, Geo. La Page, W. C. Buck, Richard Vandyke.

- 22. Received the Report of the Home Missionary, which was as follows:
- "To the Executive Board—The Association will expect a full report from me, through you. By reference to my communication in the Banner of the 12th of June, and the annexing of the following, you will have a full history: Served 76 days, rode 565 miles, accessions and applicants to the Associa-

The Missionary Board reported that they had experienced difficulty in securing the attendance of a sufficient number to form a quorum at meetings of business; and they had on hand about money enough to pay all the expenses of the concern.

The Board of last year was continued, and requested to proceed according to their own discretion.

- 23. The report of the ministers, according to a resolution of last year, in favor of supporting the Banner, was called for. G. B. Peck reported that he had obtained twenty-two new subscribers; F. Davis, two; J. Kinsolving, three; S. Thomas, (unable to state the number.)
  - 24. The following resolution was unanimously adopted:

Resolved, That whilst the interests and rights of our denomination in the South and West have been involved in the late difficulties between the Northeast and Southwest, we take pleasure in acknowledging our obligations to the Editor of the Baptist Banner and Pioneer, as the able and consistent advocate of the interests of the Southwestern Baptists; and as an evidence of the estimation which we place upon his labors, we cordially recommend the Banner to our brethren of the Southwestern States, and solicit for it a more liberal patronage.

- 25. Brethren WM. VAUGHAN, E. G BERRY, and J. D. CRABS were appointed to preach on Lord's Day.
- 26. Appointed Elder George Waller to preach the next introductory sermon; and, in case of failure, Eld. W. C. Buck.
- 27. Agreed that the next Association be held at Elk Creek Meeting-house, Spencer county, to commence on the first Friday in September, 1846.
  - 28. Appointed W. W. GARDNER to write the next Circular Letter.
- 29. Appointed the following brethren messengers to the General Association, viz: George La Page, W. W. GARDNER, G. W. Robinson, A. D. SEARS, and ISAAC McCor.
  - 30. The following preamble and resolutions were adopted:

WHEREAS, Dr. Pattison, President of the Theological Institute at Covington, has failed to answer the very reasonable inquiries of Elder J. L. Waller, as propounded to him in the Baptist Banner, therefore,

Resolved, That the Long Run Association fully sustain the course of brother Waller, and the Editor of the Banner and Pioneer.

Resolved, That from the situation in which Covington Institution is, on account of the suspicions respecting its President upon the subject of slavery, this Association deems it an unsafe place to educate the rising ministry of the Southwest.

- 31. Resolved, (unanimously,) that the Baptist Hymn Book, published by Eld. W. C. Buck, is calculated, in a high degree, to promote christian devotion, and is specially adapted to christians in the Western and Southern States; and it is earnestly recommended to churches and individuals to adopt it, and bring it into general use.
- 32. Resolved, That this Association behold, with great pleasure, the growing prosperity of the Georgetown College, and recommend it to the universal support and patronage of the friends of learning and religion.
- 33. Received money for printing the Minutes, and directed the Moderator and Clerk to superintend their printing and distribution.

Adjourned by a song of praise to God, and prayer by the President.

## CIRCULAR LETTER,

BY ELDER A. D. SEARS.

TO THE CHURCHES COMPOSING THE LONG RUN ASSOCIATION.

DEAR BRETHREN: .- The time having arrived when you reasonably expec an annual circular, we enter upon the task of preparing it under a feeling sense of the peculiar difficulties in which our beloved Zion is involved. past has been a year of unexampled spiritual declension in the church of Jesus Owing to the political excitement in which the country was involved immediately subsequent to the last meeting of your Association, the feelings of the great mass of the church were carried into the political spirit of the times. The consequence was that, while practices were tolerated in many of the churches at war with the Bible, the Lord has visited the churches with his displeasure; and therefore error and heresy has prospered, iniquity has abounded, and the love of many has waxed cold. Joined to this season of spiritual declension, other evils, and those too of the most alarming character, have threatened the church, arising from the excitement which has arisen upon the slavery question. The aggressive spirit of Abolitionism, which, with all its intolerence, has been increasing for years, and which lately, under the milder aspect of gradual emancipation, has not only insinuated itself into the counsels of the Baptist Board of Foreign Missions, thereby influencing them to pass decisions in direct violation of the Constitution of the Triennial Convention, and subversive of the rights of the churches in the slaveholding States, but has also insinuated itself to a certain extent, for the time being, into the press of our own beloved Commonwealth. The effect of all these combined evils upon the declining spirit of the churches, has been most paralyzing, and especially have the opinions avowed by our Board of Foreign Missions in their answer to the queries of the Alabama Convention, advanced the cause of infidelity and irreligion, and promoted the interest and elevated the pride of the Anti-Missionary Baptists. The foregoing is a brief description of the unfavorable influences of an irreligious character, which have been in operation, during our past associational year; and the effect of which has overclouded with gloom our denominational prosperity, and which has brought mortification to the friends of the Redeemer. The question may now very reasonably be asked by the friends of the Redeemer, what remedies shall be applied? How is the cause of the Redeemer, entrusted to our care, to be extricated from the difficulties in which it is involved? These questions are forced more imperatively upon none of the lovers of Jesus, than upon the members of the

Long Run Association. Your Association has felt the pressure of this season of gloom, as evidenced by the letters from the churches, as much as any other department of our Zion. Joined to this, you occupy a more extended border line upon the free States than any other Association of Baptists. Here the struggle upon the slavery question has to be met. Here the evils arising from that subject have to be endured. Of course, to meet the evils which will necessarily arise in our bounds, it will be necessary, while we duly remember that the Lord reigneth, that we should nevertheless determine upon a course at once firm, dignified, and pious. First, beloved brethren, we should make common cause upon the subject of missions with our brethren of the South, and carry out, in all our benevolent efforts, the spirit of the Resolutions of the Shelbyville Convention. Second, in place of having our prayers, efforts, and contributions for the salvation of the heathen of this and other lands decrease, we should increase them tenfold; and whilst remembering the heathen, and contending for our own rights against the aggressive arm of misrule, we should be attentive to the destitute in our borders. brethren, become missionaries in our families, and in the domestic circle commend the religion of Jesus. Let us become missionaries in our neighborhoods, and impress by our intercourse in the associations of life, the religion of Jesus upon our neighbors. Let us become missionaries in our churches, and, as the brethren did of old, seek out the best gifts among us, and urge upon them improvement, and encourage them to engage in the labors of the pulpit, and thus brethren you may carry out in your Association the last instructions of Jesus-"Preach the gospel to every creature," and our beloved Zion may again be revived throughout the length and the breadth of our beloved country; and the interesting missions of the Baptist Church again become prosperous, and claim, as they once did, the approbation and sympathy of the whole civilized world. Brethren, farewell. May the God of all Grace sanctify and direct you to walk in Wisdom's ways, and may you be kept by his power through faith unto salvation.
