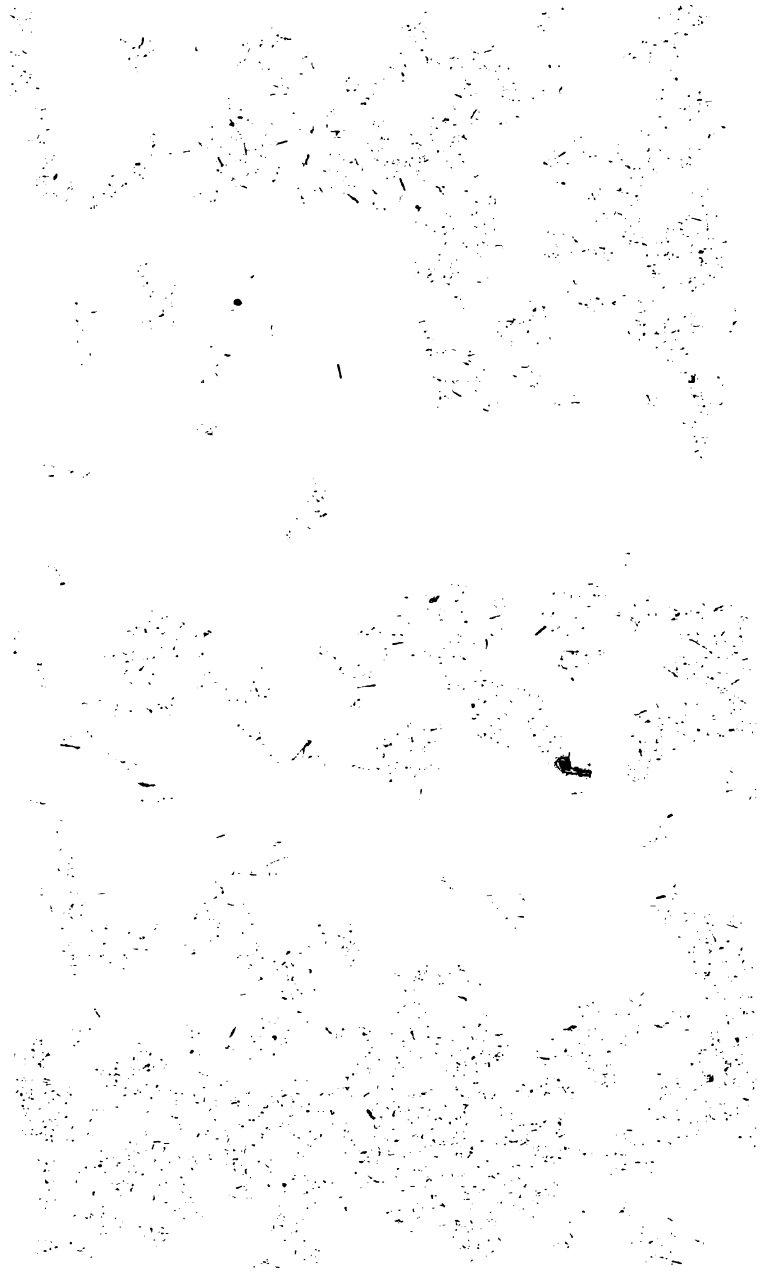

Constitution of East Union Association.

ARTICLE 1. This body shall be called East Union Association of United Baptists, and shall be composed of churches of the United Baptist faith and order.

ART. 2. Each church composing this body shall be entitled to representation with one vote for every twenty members, or fraction thereof.

ART. 3. This body shall meet annually according to adjournment.

ART. 4. This body at each annual meeting, shall elect by private ballot, a Moderator, Clerk and Assistant Clerk, whose duties shall be such as custom imposes on such officers.

ART. 5. The business of this body shall be for the advancement and growth of Christ's Kingdom among all the churches of this body or elsewhere. Planning and advising and using all lawful and necessary means in our power to build up new churches and building them up in the most holy faith.

ART. 6. This body shall exercise no ecclesiastical authority.

ART. 7. This body may appoint a committee to carry out or perform any business under Article 5..

ART. 8. This body shall be constituted by and with messengers and delegates from the different churches belonging to the Association.

ART. 9. New churches will be received by a vote of the delegates present, upon approved evidence of their United Baptist faith and principles. A majority rules.

ART. 10. Visiting brethren of same faith and order will be invited to seats with us, and allowed the liberty of speech, but not to vote.

ART. 11. The constitution may be altered or amended, except Article 6, by concurrence of two-thirds of the members present, after notice having been given at its previous annual meeting.

ART. 12. No member shall speak more than twice upon any one subject without leave of the Association. Chairmen of committees are given ten minutes, all others five, unless time is extended by the Association.

ART. 13. Members wishing to speak shall arise and address the Moderator with brotherly respect, and await recognition from him and then speak. Any brother, having received recognition from the chair, is entitled to the floor undisturbed while his five minutes last, if he does not digress from the subject on which he is speaking. Members shall call no brother by any other appellation than that of Brother.

ART. 14. Any brother may arise to a point of order if any brother digress from the subject on which he is speaking, question of privilege.

ART. 15. A motion with a second is before the Association for action unless another is made to amend, then the amendment is for action, afterwards the original.

ART. 16. No member shall absent himself from the house during the

business hours without leave of the Moderator.

ART. 17. All whispering and laughing strictly forbidden during business hours

ART. 18. Two members arising and addressing the Moderator at the same time, both claiming the floor, the one farthest from the Moderator shall be entitled to the floor first and the other next.

ART. 19. This Association may withdraw its fellowship from any church in its bounds for a violation or departure from the United Baptist faith and practice.

ART. 20. The Chair having decided any question which is thought to be contrary to the constitution of United Baptist faith, any brother may appeal from his decision to that of the house.

ART. 21. On each morning at the opening of the Association, there shall be given one hour, or such less time as may be necessary, to the offering of resolutions and such new business as is necessary.

ART. 22. If the Moderator fails to exact the rules of this constitution in the transaction of business, any member of this Association may move him to order, if he fails to exact such rules the Assistant Moderator shall take the Chair.

It is ordered that this Association adopt Mell's Parliamentary Practice for our guide in the transaction of the business of our Association.

REPORT ON ORPHANS HOME.

James says, Pure religion and undefiled before God and the Father is this: "To visit the fatherless and widows in their afflictions, and to keep himself unspotted from the world." And again he says, "If a brother or sister be naked and destitute of daily food, and one of you say unto them, 'depart in peace, be ye warmed and filled,' notwithstanding ye give them not those things which are needful to the body; what doth it profit?"

There are in our state large numbers of poor orphans. Jesus said: "Ye have the poor with you always and whenever ye will ye may do them good." To act in obedience to God's word we have our Orphans Home. There we care for some of these poor orphans. At last report the Home had 69 orphans in it. These orphans are educated and taught to work as soon as they are old enough. The expense is \$8.33 per month for each child. The income is not sufficient for the demand. There are many orphans in the state that need to be cared for. The Home needs to be enlarged. That will

take money. We would therefore recommend that each church take a collection for the Home the coming year. Also that we at this time take a collection for the same.

REPORT ON STATE MISSIONS.

We had a most prosperous year in State Missions, notwithstanding the protracted illness of our indefatigable secretary. More money has been raised and more work has been accomplished than in any previous year, and that, too, in the face of many difficulties. Our secretary has shown himself master of the situation, and the man in the right place. We have not, however, filled the measure of our duty. Much destitution remains to be compassed and much desirable work remains yet unaccomplished. We ask our people to give more attention to this matter. Schools are generally needed and several have been established and are in successful operation. Our statistics for the past year are as follows: Missionaries employed 91; days of labor 13,491; miles traveled 73,248; sermons preached 6,552; professed conversions 1,392; baptisms 781; total admissions on mission fields 1,556.

Brethren, much land remains to be possessed and development is the thing needed in our mission field. State mission work is basal work. Let us not neglect it brethren, but pray for its success.

REPORT ON TEMPERANCE.

We, your committee on Temperance, report as follows: We are glad to call your attention to the fact that the homes and Churches are beginning to be awakend to the many and great evils of intemperance, and are becoming willing to act and vote as they pray. The last Tennessee Legislature passed what was known as "The Four-mile Law" or "Adams Bill." We find that something over 4 dozen towns of Tennessee took advantage of this law, even before it was on our statute books, to rid themselves of the saloon, proves beyond a doubt that the people are gradually and surely growing tired of the whiskey traffic. We are very hopeful that our next Kentucky Legislature will pass what is known as the "Unit Bill." We further urge the pastors of the different churches to preach the straight Bible doctrine along this line.

REPORT ON HOME MISSIONS

We, your committee on Home Missions beg leave to make the following report: The territory is vast. The numbers crowding our cities of the south and west will require a great effort on our part to meet them. Let us do something in this great work. A summary of the work of the past year is as follows: \$116,452.82 increase over last year; \$9,671.75 over the previous year. Of this amount Kentucky contributed \$11,331.21. Expenses for collecting this sum was \$399.97. Paid Home Missions in the State \$3,727.08. Cash contributed outside the state was \$7,204.16. Kentucky stood fourth in cash contribution in Home Missions. In boxes sent to Home Missionaries was \$4,280.80, given by Kentucky, giving her first place in these gifts. The board employed 671 missionaries. There were 8,969 baptisms. Total additions to the church 18,690. The Board asks for \$200,000 this year. We request each church to give liberally to this mission. May

God give us a more prosperous year than ever before.

REPORT ON FOREIGN MISSIONS.

We, your committee on Foreign Missions submit the following report: Our Foreign Mission work at present covers six fields, to wit. China, Africa, Italy, Pagan, Mexico, Brazil, Japan, Papal. In these six fields we have 127 missionaries, which is an increase of 12 over last year, and we have 192 native helpers, which is an increase of 21 over last year. Their report at the Southern Baptist Convention last May was received. 1,790 by baptism, which was an increase of 351 over the previous year. We find that the collections or contributions amounted to \$218,512.62, which is an increase over the previous year of \$4,573 13. Wherein we find Kentucky contributed of that amount \$23,241.77. At the last convention the convention advised the Board to lengthen their cords and strengthen their stakes, and the Board asks Kentucky this year to contribute \$30,000. The East Union Association gave \$66.67 last year. How much shall we give this year? Let every member of the Association ask themselves the question. How much ought I to give? Let us pray over this question, as the missionaries request that we may be stirred in our hearts by the power of the Holy Spirit to missions in all of the world, by going or helping someone else to go in accordance to our Savior's great command.
